1. EXPLANATION OF THE WORK CARRIED OUT BY THE BENEFICIARY AND OVERVIEW OF THE PROGRESS

ASERSA is a professional, non-profit association registered in the EU Transparency Register since 26 October 2014 under the name of Asociación Española de Reutilización Sostenible del Agua whose translation into English is "Spanish Association for Sustainable Water Reuse".

ASERSA has contributed actively to the project activities until the contract termination. In this sense, ASERSA has committed with its responsibilities as project beneficiary (e.g. attending meetings, providing inputs for deliverables and complying with administrative and reporting responsibilities.).

The present Termination Report is focused on the activities carried out by ASERSA during the second period until the termination date.

During the second period, ASERSA has worked exclusively in task 3.1 Under this task, ASERSA developed two fact-sheets within info-package 6 devoted to provide practical knowledge adapted to the needs of the target group "Authorities and policy makers". Both fact-sheets are intended to explain main features of new EU regulation on water reuse for agricultural irrigation which has been recently approved: i.e. REGULATION (EU) 2020/741 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 25 May 2020 on minimum requirements for water reuse.

Within WP3, ASERSA has developed two fact-sheets in the frame of task 3.1. These two fact-sheets belong to info-package 6 which is focused on practice information for authorities and policy makers. The topics of the fact-sheets are:

• Fact Sheet 6.1 – New EU Regulation on reclaimed water for agricultural irrigation

• Fact Sheet 6.2 – Water Reuse Risk Management Plans.

Fact-sheet 6.1 outlays the previous publications and deals made by the European Union to regulate the use of reclaimed water for agricultural irrigation. More specifically the 2012 publication of the Commission's Communication on "A Blueprint to Safeguard Europe's Water Resources" as well as the "provisional deal on water reuse for agricultural irrigation" announced in December 2019 by the Council of the EU.

The fact sheet summarizes the contents of the proposed "Regulation of the European Parliament and of the Council on minimum requirements for water reuse", which includes a series of 16 Articles and 2 Annexes, summarized with the most relevant topics.

Fact-sheet 6.2 addresses the requirement of conducting risk management plans according to the water reuse regulation. Since the proposed "European Regulation on minimum requirements on water reuse" specifically points out the need for including the risk evaluation to correct the limited extent of water reuse in EU thus far. The fact sheet goes in detail on risk management as is proposed in the Regulation. It includes the summary of all the most relevant provisions related to risk and risk management issues, as required by the Regulation. It epitomizes all the articles in which risk management is mentioned, such as Article 1, Article 2 and Article 5, and specifically focusing on the Annex II since it is entirely devoted to describing the key elements of risk management. The fact sheet includes a set of provisions for identifying and quantifying the risks involved in the reclaimed water use.

2.1.Tasks

ASERSA has completed its task within WP1 and WP2 as described in Annex I with no deviations.

The intention of ASERSA to terminate the Grant Agreement was communicated in early 2020. It was then agreed with the Coordinator that ASERSA will finish the completion of the two fact-sheets assigned to ASERSA within task 3.1 related to info-package number 6. This work has been completed with no deviations.

Rest of the tasks in WP3 are assumed by BIOAZUL including the following:

- Translations of fact-sheets into Spanish within task 3.1
- Organization of a training workshop within task 3.2
- Audio-visual material for the e-learning platform within task 3.5
- Policy briefs within task 3.6

In WP4, BIOAZUL assumes the contribution of ASERSA within task 4.2.2 related to producing practice abstracts following the EIP-Agri template.

More intense dissemination activity will be also conducted by BIOAZUL to compensate for AERSA's absence during the rest of the project.

Costs incurred by ASERSA present the following deviations:

Personnel costs declared are lower than expected

This deviation is due to:

ASERSA has only participated in task 3.1 during the second period. Contract termination implies the no participation in the rest of the foreseen tasks of the second period.

Moreover, a deviation in the average personnel costs estimated for ASERSA: 2,500.00€ foreseen and 869.02€ claimed (deviation -65.24%). Average personnel costs were lower than expected. The monthly rate was estimated during the proposal preparation considering the need of hiring additional staff once the project started because of the limited capacity of ASERSA. However, this estimation did not respond to the reality. The estimated monthly rate was too low to employ a highly qualified expert in water reuse. It was then considered to hire a less qualified professional who would be under guidance of the ASERSA team and lower monthly rate was finally needed. Likewise, the new staff was working part time with exclusivity for working in SUWANU EUROPE. We started with a 10 h/week contract, from 15 June 2019, expecting to increase that time load during the second part of the project where more intense work of ASERSA was expected

Travel costs declared are lower than expected

This deviation is due to:

- Contract termination implies the no participation in the rest of the foreseen meetings of the second period.
- Only one person from ASERSA attended the meeting in Rome, Mr. Rafael Mujeriego, while two people were expected to travel. Likewise, plane tickets and accommodation rates in Rome have been lower than estimated. In table 3.4 of Annex I, part B, travel expenses estimated for attending 2nd GM in Italy are EUR 625/person while Mr. Mujeriego reported travel costs accounting for 329.29 Euros.

There are no costs incurred in other goods and services. 0% of other goods and services have been justified by ASERSA between periods 1 and 2.

ASERSA had allocated 3,250 Euros as other goods and services. These costs included consumables for project events $(1,000.0\mathbb{E})$, printing dissemination material in English and Spanish $(750\mathbb{E})$, costs related to the organisation of project events in Spain (venue, catering, etc.) $(1,500.0\mathbb{E})$

These resources were reserved for the organization of the training workshops in the frame of task 3.2. However, this task has been assumed by BIOAZUL as well as the corresponding resources. ASERSA has not participated in the organization of the workshop and therefore incurred in no costs.

Deviations:

The number of person-months needed by ASERSA to carry out the project activities have been higher than estimated in the DoA. In particular, for WP3 This is explained because the estimation of person-months during the proposal preparation was done taking into account a full-time staff working on the project, however, ASERSA hired a part-time employee to develop their activities. The staff person involved in the project had an exclusivity contract to work on SUWANU EUROPE. As indicated by e-mail by the financial officer on 25/02/2020, one month of dedication to the project corresponds to 1 person-month, even if the staff person was part-time employee and worked less hours than a full time employee. This situation has resulted in higher number of person-months than foreseen for WP1, WP2 and WP3.

On the other hand, ASERSA did not justified person-months for WP4 and WP5 as foreseen. ASERSA contribution to these WPs has been negligible in the second period.

2.2.3. Transfer of budget resources from ASERSA to other partners

Remaining budget resources from ASERSA has been transferred to BIOAZUL jointly with the responsibility of carrying out the pending tasks. Table below shows the transfer of resources:
